Companion Animal Information

Airdrie Housing Limited (the landlord) allows companion animals in its units where appropriate; however the tenant(s) must have written permission to have a companion animal. Failure to do so may result in a breach of the Affordable Housing agreement. Residents in condominium units are bound by the bylaws of the condominium corporation with respect to pets.

Companion animals with the exception of service dogs are limited to:

- Those which may legally reside in Canada;
- Those which weigh 10 kilograms (22 pounds) or less. Airdrie Housing may limit the number of companion animals per unit to two.

Companion Animal Regulations

Tenants who would like a companion animal must agree to and comply with the following regulations. Failure to do so may result in a breach of the Affordable Housing Agreement.

1. Companion animals must be accompanied by their owners at all times when outside of the unit and on Airdrie Housing property.
2. Companion animals must be on a leash at all times when on Airdrie Housing property and outside of the housing unit. This includes, but is not limited to, building hallways, laundry facilities and parking lots.
3. In conjunction with the City of Airdrie bylaw, all dogs must be licensed and those licenses must be renewed annually.
4. Tenants whose companion animals defecate on Airdrie Housing property shall remove the matter immediately and dispose of it appropriately.
5. Tenants are financially responsible for damage to Airdrie Housing property which is caused by their companion animal.
6. If significant noise complaints are made with regard to the companion animal, the tenant may be asked to find a new home for the animal.
7. When off Airdrie Housing property, companion animals must comply with City of Airdrie animal control bylaws. Non-compliance is punishable by fine or confiscation of the companion animal. City bylaws may be reviewed at www.airdrie.ca
